



## Large Event Contract

(Including Festivals, Corporate Events, Events open to the public etc)

\$150 per hour paid on the event date via cash or check make out to Color Pop Facepaint  
2.5 hour minimum

48 hour rescheduling/cancellation notice required to change the date to another available date/time or cancel the event. If the event is canceled within 48 hours before the start time, 50% of the quoted total is due for holding the date.

There is a \$60 tent fee if you are unable to provide an indoor or covered area.

### Setup for all Events

We will provide all necessary equipment to set up, paint, and dispose of our trash. For small private events our artist needs a 5' x5' area. Larger events may require multiple artists, equipment and a minimum of a 10'x10' area.

\*A tip jar will be set out for events unless otherwise requested.\*

**PLEASE NOTE FOR OUTDOOR EVENTS:** - Space provided must be out of the elements (rain, splash pad, sprinkler systems etc) and in a shaded area or our face paint will melt and we will be unable to paint. If a tent is required and you are not able to provide one, please let us know in advance.

If the event is outside during the **fall/winter months** please have a backup indoor area planned for setup. Since we spray water to activate our paints we need to ensure that the paints do not freeze, if this occurs we will be unable to paint.

**Animals** : For hygienic and safety purposes, the host agrees to keep all animals clear of the face painting workstation. This ensures a clean and sanitary environment for both the artist and the participants. Additionally, this helps prevent potential distractions or disruptions during the face painting process.

## Travel/Setup/Other Fees

Travel Fees apply when the event is more than 30 minutes from Slinger, WI. Generally, \$30 per artist per half hour increment.

Example: The event is 1 hour away from Slinger: The first 30 mins are free, then \$30 fee for the remainder and \$30 for the return trip = \$60 total travel fee

Parking fees must be paid to Artist with other payment.

Should a check be returned, there is a \$30 returned check fee.

## Overtime and Breaks:

Any time beyond the time booked will cost \$130 per hour, or \$65 per half hour, per Artist, with a full half hour charge being due for each 1-30 minutes of overtime. However, only booked times are guaranteed, additional time on the day of the event may not be available, although Artist will attempt to accommodate requests for additional paid time.

Artists will have paid breaks of 5-10 minutes every two hours as needed and access to a restroom.

## Extreme Adverse Working Conditions:

Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the client fails to remedy the situation after it has been brought to the client's attention. Adverse conditions included but not limited to : destructive, violent, or extreme inappropriate behavior of a child, pet, or adult illegal activities; or otherwise dangerous conditions.

## Policies:

Color Pop Paint is fully insured.

Face paints used have been designed for professional use and comply with all the FDA cosmetic regulations. Many children are allergic to or have a sensitivity to a wide range of common products or ingredients. We are not responsible for any such reactions.

If you have any concerns regarding your child's reaction to face paints, please discuss with the artist BEFORE your child is painted. [Ask for a patch test half an hour in advance, and we will paint a small motif on the hand]

If your child has very sensitive skin or is ALLERGIC to COCONUT OIL, ALOE, or RED DYE, please inform the artist.

We will not paint anyone who, in the opinion of the face paint artist, appears to be suffering from : Cold Sores; conjunctivitis; any infectious skin complaint; open wounds, or similar. We will not paint children who are infants or children under duress.

Artist will use reasonable care, but is not responsible for damage to clothing or property. The Client agrees to pay for any accidents or injuries caused by pets or guests, and/or damage to Artist's equipment or supplies caused by pets, lawn sprinklers, or guest.

**Under no circumstances will Artists supervise children. Their behavior and safety is the Client's and/ or Parents' responsibility.**

**Artist will always ask permission to take photos to use online/ in marketing materials.**

## Paint Removal:

To REMOVE face paint: Scrape off any chunky glitter with a business card - swiping away from the eyes. Then, gently massage a no tears baby shampoo or gentle soap onto the design and blot away with a wet washcloth or gentle baby wipe. If paint remains on the skin after being washed, use lotion or coconut oil to gently remove.

CLOTHING that has been in contact with face paint should be COLD soaked overnight with an oxygen activated stain remover before washing normally.

## Conclusion:

This contract does not go into effect until the Google form attached to the clients booking email has been submitted; all dates and times must be agreed upon by both parties. Full/final payment must be received upon our arrival to paint.
