



## Birthday Party Contract

**Rate: \$130 per hour with a 2 hour minimum**

**Cash or Check made payable to Color Pop Facepaint is due on the date of the event.**

Any more than 10 guests will require booking more than 2 hours. If you're not sure how long to book us - we are happy to advise you.

A 48 hour rescheduling/cancellation notice is required to change the date to another available date/time or cancel the event. If the event is canceled within 48 hours before the start time, 50% of the quoted total is due for holding the date. Rescheduling will be subject to Color Pop Face painting's availability.

There is a \$60 tent fee if you are unable to provide an indoor or covered area.

**\*Please note facepaint is WATER activated meaning it will begin to wash off when it touches water. Kids will need to be completely done with splash pads/sprinklers/pools etc before receiving any facepaint.\***

## Setup for all Events

We will provide all necessary equipment to set up, paint, and dispose of our trash. For small private events our artist needs a 6' x6' area. Larger events may require multiple artists, equipment and a minimum of a 10'x10' area. There is a \$60 tent fee if you are unable to provide an indoor or covered area.

PLEASE NOTE FOR OUTDOOR EVENTS: - **Space provided must be shaded**, or our face paint will melt and we are unable to paint. If a tent is required and you are not able to provide one, please let us know in advance.

## Breaks

Artists will have paid breaks of 5-10 minutes every two hours as needed and access to a restroom.

## Extreme Adverse Working Conditions

Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the client fails to remedy the situation after it has been brought to the client's attention. Adverse conditions included but not limited to : destructive, violent, or extreme inappropriate behavior of a child, pet, or adult illegal activities; or otherwise dangerous conditions.

## Overtime

Any time beyond the time booked will cost \$130 per hour, or \$65 per half hour with a full half hour charge being due for each 1-30 minutes of overtime. However, only booked times with deposits are guaranteed, additional time on the day of the event may not be available, although the artist will attempt to accommodate requests for additional paid time.

## Travel/Setup/Other Fees

Travel Fees apply when the event is more than 30 minutes from Slinger, WI. Generally, \$30 per artist per half hour increment.

Example: The event is 1 hour away from Slinger: The first 30 mins are free, then \$30 fee for the remainder and \$30 for the return trip = \$60 total travel fee

Parking fees must be paid to Artist with other payment.

Should a check be returned, there is a \$30 returned check fee.

## Policies

Color Pop Paint is fully insured.

Face paints used have been designed for professional use and comply with all the FDA cosmetic regulations [As with any cosmetics, some people may develop sensitivity to one of the ingredients]. Many children are allergic to a wide range of common products. We are not responsible for any such reactions.

If you have any concerns regarding your child's reaction to face paints, please discuss with the artist BEFORE your child is painted. [Ask for a patch test half an hour in advance, and we will paint a small motif on the hand]

If your child has very sensitive skin or is ALLERGIC to COCONUT OIL or RED DYE, please inform the artist.

We will not paint anyone who, in the opinion of the face paint artist, appears to be suffering from : Cold Sores; conjunctivitis; any infectious skin complaint; open wounds, or similar. We will not paint children under the age of 2 years of age or that are under duress.

Artist will use reasonable care, but is not responsible for damage to clothing or property. The Client agrees to pay for any accidents or injuries caused by pets or guests, and/or damage to Artist's equipment or supplies caused by pets, lawn sprinklers, or guest.

**Under no circumstances will Artists supervise children. Their behavior and safety is the Client's and/ or Parents' responsibility.**

To REMOVE face paint: gently massage a no tears baby shampoo or gentle soap onto the design and blot away with a wet washcloth or gentle baby wipe. If paint remains on the skin after being washed, use lotion or coconut oil to gently remove.

CLOTHING that has been in contact with face paint should be COLD soaked overnight with an oxygen activated stain remover before washing normally.

This contract does not go into effect until the deposit is received to secure your date; all dates and times are agreed upon by both parties. Full/final payment must be received upon our arrival to paint.
